### Update from Tala Community Council - Green Areas and Cleaning of Tala

Owing to the volume of growth, due to the sustained rainfall, the risk of fires this summer is very high. Please be vigilant.

The Committee have since met with Areti (the Mukhtar) regarding the above plus the Road diversions around Tala, and we will follow up the progress before the end of the month.

### Koili

An Inspector from The Paphos District Office has the now accepted the illegality of the imposed water charges on certain Zelemenos residents by the Koili Community Council. The claimants are now eagerly awaiting receipt of their refunds, hopefully by the end of this month.

### Neighbourhood Watch Scheme - update from Nikoletta the N.W.S. Police Co-ordinator,

The scheme is still on-going - with reminders that high quality locks are paramount in domestic protection, and that all burglaries should be reported to the Police - irrespective.

It would appear that there seems to be a breakdown in relationships between both the N.W.

Committee and the Police at present.

# Limni mine by Maggie Wright

Cyprus gave its name to copper – Kipros in Greek and cuprum in Latin - due to the abundance of high quality of copper. Copper was brought down from the nearby mines and loaded onto ships for export from the Limni jetty.



Limni mine is an abandoned copper and sulphur mine which at some point in the future may become a golf course. The slag heaps are fascinating places, a myriad of interesting rocks and minerals. Limni copper mine closed in 1979. The Cyprus Sulphur and Copper Co., Ltd., a subsidiary of Esperanza Trade and Transport Ltd., held the mining lease over 30 square miles of northwest Cyprus. In Roman times the Limni deposit was one of the most important mines worked.



The long continuous and intense mining activity in Cyprus is evident from the presence of slag deposits (remnants of ancient copper exploitation) scattered all over the island.

## Cyprus Health Service - GHS

The General Healthcare System (GHS) is a modern, patient-centric healthcare system with the aim of delivering quality healthcare services to beneficiaries.

The main features of the system are:

- Universal coverage of the population
- Equal and equitable treatment of all beneficiaries
- Provision of a comprehensive package of healthcare services
- Freedom of choice of provider by the beneficiaries
- Social reciprocity

For the implementation of the GHS, a special fund was established for purposes of gathering the relevant contributions, and from which all payments to providers of healthcare services will be made. The GHS fund will be administered by the Health Insurance Organisation (HIO).

The first part of Cyprus' new public health system is due to come into force on June 1.

A list of ten things that citizens should know about the GHS was published on the system's website recently.

### 1 Which healthcare services are covered?

- Healthcare services by personal doctors
- Healthcare services by specialist doctors
- Pharmaceutical products
- Laboratory tests
- Inpatient healthcare services
- Healthcare services in cases of accidents and emergencies
- Ambulance services
- Healthcare services by nurses, midwifes, clinical psychologists, clinical dieticians, physiotherapists, occupational therapists and speech pathologists
- Preventive dental healthcare services
- Palliative healthcare and medical rehabilitation

### 2 When will it come into force?

### • 1st June 2019

Introduction of specialist doctor and personal doctor services, laboratory tests and pharmaceutical products for outpatients.

### • 1st June 2020

Complete implementation of the GHS with the introduction of inpatient services, Accident and Emergency Department (A&Es) services, ambulance services, services by nurses, midwives, allied health professionals, palliative care, medical rehabilitation, preventive dental care and home visits

#### 3 Who are the beneficiaries?

All citizens who are permanent residents in the areas controlled by the Republic of Cyprus and come under one of the following categories:

- Cypriot citizens
- European citizens who work or hold a permanent residence status in accordance with the provisions of the national legislation
- Third country nationals (non-EU citizens) who hold a permanent residence status or a right of equal treatment in accordance with the provisions of the national legislation
- Members of the families of the above categories in accordance with the provisions of the national legislation
- Refugees and persons with a status of supplementary protection

### 4 How do beneficiaries have access to healthcare services?

Beneficiaries have access to healthcare services after they enrol in the GHS and register in a personal doctor's list of their choice.

Beneficiaries can enrol in the GHS and register with a personal doctor either online or by visiting a personal doctor.

Personal doctors will be the first contact point of beneficiaries with the GHS and are responsible to provide all required healthcare services as well as to guide and refer the beneficiaries to more specialised healthcare services when and if this is needed.

Beneficiaries may choose the specialist doctor, pharmacy, laboratory, hospital or any other private or public healthcare provider they wish.

### 5 Who will contribute to the GHS and how much?

Employees	1.70%	2.65%
Employers (including the State)	1.85%	2.90%

Self-employed	2.55%	4.00%
Pensioners	1.70%	2.65%
Income earners (interest, rent dividends, etc.)	1.70%	2.65%
Officials	1.70%	2.65%

Contributions will be collected by the Social Insurance Services, the Tax Department and the Treasury of the Republic.

### 6 What are Co-Payments and when do they apply?

Beneficiaries will pay small amounts of co-payments upon receiving services by outpatient specialists, laboratories, pharmacies, nurses, midwives, allied health professionals, and A&Es such as for example:

€1 per pharmaceutical product, €1 per laboratory test, €6 per visit to a specialist doctor. It is noted that access to personal doctors and inpatient healthcare is free.

The annual co-payment ceiling per person is:

- General population: €150 | Low-income pensioners: €75
- Recipients of the Guaranteed Minimum Income benefit: €75 | Children: €75

#### 7 What does the GHS cover?

The GHS covers all medical care needs of beneficiaries including chronic, rare and serious conditions.

### 8 How is the quality of the healthcare services provided assured?

The GHS planning applies best practices that aim at upgrading the quality of healthcare services such as the introduction of the personal doctors, the implementation of guidelines and the use of a comprehensive IT system.

9 Are high-cost healthcare services covered?

The GHS provides lifelong financial protection to all beneficiaries even for unexpected and costly healthcare needs.

### 10 Are citizens without an income covered?

The right to health within the GHS is independent from the payment of Beneficiaries without an income (unemployed, children, students, soldiers and others) have equal access to healthcare services.
